### EXPRESSION OF INTEREST FOR APPOINTMENT OF MEMBER OF THE BOARD OF CIVIL AVIATION SAFETY AUTHORITY OF PAPUA NEW GUINEA (CASA PNG)

The **Civil Aviation Act 2000** (as amended) stipulates that a Board for CASA PNG, shall comprise of seven members, three ex-officio and four independent members.

The **Civil Aviation Act 2000** (as amended) provides that before making any recommendation for the appointment of independent members, the Minister for Civil Aviation shall request expression of interest from suitable candidates to be considered for appointment from such organizations, as the Minister considers necessary. Interested candidates should have a substantial interest and experience in the fields of aviation safety management, aviation industry, law and community affairs.

Four Independent Board Members vacancies will exist from the 6th October 2025. As Minister responsible, I am exercising my power under Section 20(2) of the Civil Aviation Act 2000 (as amended) to call for expression of interest from persons who have the necessary qualification and experience in the fields of aviation safety management and aviation industry to directly apply to be considered for appointment.

#### **Requirements:**

Persons interested to be appointed as a member of the board of CASA PNG must meet the following criteria:

- be competent and of sound judgement for fulfilling the duties of a member of CASA; and
- possess professional skills or wide industrial or management experience, and has the ability to participate meaningfully as a member of CASA; and
- have a reputable standing within the community and be unlikely to do anything to undermine the interest of Papua New Guinea in favour of personal, business or other interests; and
- is of good character

#### **In addition, the person interested must not:**

- have a criminal conviction of any offence (or found liable civilly for any claim) involving fraud or dishonesty of which may diminish the integrity or reputation of CASA or have been charged with any such offence and awaiting trial.
