**Instructions:**

This form is to be used to notify CASA of a proposal to operate a light or laser which is likely to endanger aircraft operations in navigable airspace under Rule 77.7(b). \*

\* This notification is not required if the proposal to use a light or laser is within a control zone or air traffic zone when the appropriate ATC unit is on duty, in which case the proposer must obtain prior authorisation from ATC unit.

This notification is to be submitted to the CASA at least 5 working days' notice prior to the proposed date of the activity.

**NOTE:**

The provision of false information or failure to disclose information relevant to the grant or holding of an aviation document constitutes an offence under Section 304 of the Civil Aviation Act 2000 and is subject, in the case of a person other than an individual, to a maximum fine of K100,000.
