Civil Aviation Safety Authority PNG (CASA PNG) has requested the Authority Pre-Commit Committee (APCC) to provide financing under GoPNG to support the preparation of the Feasibility Studies, Environment and Social Safeguards Studies, Gender Analysis, Detailed Designs and advance procurement actions.
2. Civil Aviation Safety Authority (CASA PNG) ("Client") seeks expression of Interest (EOIs) from interested and eligible consulting firms, who possess extensive local and international experience, for the above Consultancy project.

The Consultants will be recruited following GoPNG procurement process, quality and cost-based selection (QCBS) method under Open Competitive Bidding (OCB) and submission of full expression of interest. All consultancy firm selection will be carried out in accordance with the Terms of Reference (TOR) requirements, GoPNG procurement process and NPA regulations. Only the firms that have been shortlisted shall be invited to submit Technical and Financial Proposals.

The EOI should contain detailed information about (i) consultant's similar experience (i.e., preparation of feasibility studies, detailed engineering designs, environmental and social safeguards studies, preparation of bidding documents, etc.), (ii) technical and managerial competence, (iii) experience in developed and developing countries of Oceania/ Pacific and Asia, and (iv) availability of/access to Experts whose qualifications and experience are relevant as per the Terms of Reference (TOR). In addition to the information provided in the structured EOI template, the Consultants are encouraged to provide additional information (including brochures, reports, references from previous clients, if any, etc.) to demonstrate that they have the required qualifications and relevant experience to perform the services.
